Sisters of Charity of the Immaculate Conception of Saint John

In 1875, following the introduction of the Common Schools Act a few years earlier, the government took over control of

education and the Sisters began to prepare themselves for the provincially prescribed licensing examinations. By 1882 the Sisters of Charity ventured into what was at once recognized as a characteristic of urban living in the late 19th century, the displacement of the elderly. They acknowledged a growing need within the community to care for the infirm. In 1888 the Sisters of Charity opened the first nursing home in the city, the Mater Misericordiae Home.

By 1906 in New Brunswick the Sisters of Charity of Saint John had grown to include over 100 Sisters and many new women were entering the convent. By this time the population growth in western Canada was exploding due to the completion of the railway, whereas in New Brunswick population growth had stagnated. The Sisters felt that their mission in New Brunswick was stable so when an invitation came from Prince Albert in the newly formed province of Saskatchewan, they responded. There they took over the operation of St. Patrick's Orphanage which had been in existence since 1899.

Before the Sisters of Charity arrived, the orphanage had been staffed by a French speaking community, the Sisters of Providence. However, the late-nineteenth and early-twentieth century immigration trends within Canada produced an immense increase in English-speaking population in Saskatchewan. The orphanage had received 60 British orphans, some of the 125,000 who had been abandoned and sent to western Canada as the Industrial Revolution took hold in England.

The local inhabitants of Prince Albert, were so impressed with the orphanage that they appealed to the Sisters to open a new hospital to replace their small 16 bed hospital.

After much consultation, they accepted the call and began their first in a new ministry—Health Care. They purchased land, oversaw construction and sent several Sisters away to be trained as nurses. On Christmas day in 1910, the Holy Family Hospital opened its doors to their first patient who arrived with a "quinsy" sore throat. The doctor prescribed ice, but there was none, so the sisters packed snow and used that until the water they placed outside froze. Within a few days the hospital was filled to capacity, and consisted of 32 beds and an operating room to serve the region. To be continued...



Mount St. Joseph, Miramichi NB

On July 16, 1869, five Sisters from Hotel Dieu of Montreal disembarked at Chatham, NB, where they had accepted the responsibility of taking care of the sick, to open a boarding school for young girls and an orphanage. Their hospital work also began in 1869 in the Bishop's former residence, which also served to house the Sisters for some months.

This modest start was the beginning of 127 years of service of the Religious Hospitallers of St. Joseph to the Miramichi region.

In celebration of the Feast of St. Joseph each year, the Mount recognizes their mission through special activities. This year they decided to honour the history of the RHSJs and specifically Sister Isabelle MacLaughlin, who is the last in a long line of Sisters. Soon she will retire, and it will be the end of an era. This is her story.

Highlights from the meeting of the Directors held April 4, 2012:

- ⇒ Insurance survey of facilities completed and submitted to CRSIRP
- ⇒ Financial/Investment statements reviewed and accepted.
- ⇒ All Canonical approvals were up to date.
- ⇒ Concurrent meetings were held for the following Corporations:
 - St. Bernard Health Network – Members - Chicago, IL
 - St. Bernard Health Network – Trustees - Chicago, IL
 - Hôpital Stella-Maris-de-Kent, - Ste Anne de Kent, NB
 - Overview – Hotel-Dieu Grace Hospital – Windsor, ON
- ⇒ Approval for the construction of a filtration plant at Ste. Anne de Kent, NB was granted.
- ⇒ Board received an update of the work of the Board of Governor`s of the Catholic Health Alliance of Canada.
- ⇒ Discussion of the impact of the Federal Budget and the provincial budgets of Ontario, New Brunswick and Nova Scotia.
- ⇒ Update provided on the Values Integration Assessment Program – announcements to be made at the CHAC conference in St. John`s NFLD in May.
- ⇒ The French Catholic Healthcare Leadership Program scheduled to begin in Bathurst on April 11th with 21 students.

- ⇒ An Environmental Scan of the CHI System was presented to the Board with an update on all operations.
- ⇒ CHI Corporate Representative policy was presented and approved.
